## ORDINANCE NO. 4003

An Ordinance rezoning certain property from a County LI (Light Industrial) zone to a City zone of M-2 (General Industrial) planned development on a parcel of land approximately 25 acres in size located on Three Mile Lane (Evergreen).

WHEREAS, the Planning Commission received an application for a zone change (ZC 1-79) dated January 19, 1979 on property of Evergreen Helicopters, Inc., located on Three Mile Lane, further described as Tax Lots 101 and 102, Section 26, T. 4 S., R. 4 W.; and

WHEREAS, a public hearing was held on February 8, 1979 at 7:00 p.m. before the Planning Commission after due notice had been given in the local newspaper on January 29, 1979 and written notice had been mailed to property owners within 300 feet of the affected property; and

WHEREAS, at said public hearing the testimony of the applicant and surrounding property owners was received and a staff report was presented; and

WHEREAS, the Planning Commission being fully informed about said zone change, and based on the observations and the findings of fact has approved said zone change and has recommended said change to the Council; now, therefore,

THE CITY OF McMINNVILLE ORDAINS AS FOLLOWS:

Section 1. That the Council adopts the findings and conclusions of the Planning Commission, staff report on file in the Planning Department, and the application filed by Delford M. Smith, President, Evergreen Helicopters, Inc.

Section 2. That the property described in Exhibit "A," which is attached hereto and by this reference incorporated herein, shall be rezoned from a County LI (Light Industrial) zone to a City zone of M-2 PD (General Industrial) planned development, subject to the following conditions:

(a) Plans must be submitted to and approved by the McMinnville City Council for (1) any change in the site's current access points onto Three Mile Lane, (2) any proposed new access points onto Three Mile Lane, and (3) any future change in the onsite circulation system. The construction of the 24,000 square-foot office building which is planned for this year is exempt from part (3) of this condition.
