The above-described property is contiguous to the City of McMinnville, Oregon; and

The Council of the City of McMinnville, Oregon, believes it may be appropriate that said property be annexed to the City of McMinnville, Oregon, in order that said property may obtain water and sewer for domestic use, if available; and

The Council of the City of McMinnville, Oregon, elects to dispense with submitting the question of annexation of said area and territory to the registered voters of the City of McMinnville, Oregon, and desires that a public hearing be held before the Council of the City of McMinnville, Oregon, upon the question of the annexation of said property hereinabove described as provided by Section 222.170, Oregon Revised Statutes; and

Said area and territory described in Exhibit "A" is a part of the McMinnville Rural Fire Protection District; McMinnville Rural Fire Protection District has no liabilities or indebtedness; and the City of McMinnville, Oregon, is furnishing fire protection to the McMinnville Rural Fire Protection District under a contract between said municipalities; and

It appears to the Council that the area and territory above described should be withdrawn from said McMinnville Rural Fire Protection District, subject to the approval of the annexation of said area being final, and pursuant to ORS 222.524, et sec., it is necessary to hold a public hearing on the question of such withdrawal at which hearing the Council of the City of McMinnville shall hear objections to such withdrawal and determine whether such withdrawal is to the best interests of the City; now, therefore,

Section 1. That the Recorder of the City of McMinnville, Oregon, is hereby authorized and directed to cause notice of said hearings to be published once each week for two successive weeks prior to the day of said hearing in the News-Register, a newspaper of general circulation published in the City of McMinnville, Oregon, and to cause notices of said public hearings to be posted in four public places in the City of McMinnville, Oregon, for a period of at least two weeks prior to said hearings, and such notice shall describe the area and territory proposed to be annexed to the City of McMinnville, Oregon, and withdrawn from McMinnville Rural Fire Protection District, described in Exhibit "A" which is attached hereto and by this reference incorporated herein, and the registered voters of the City of McMinnville shall be invited to appear at said public hearings and be heard on the question of such proposed annexation and withdrawal.

Whereas, the above-described area and territory is without the City and may not receive City services until annexed and the Council is desirous of proceeding with these hearings as soon as possible, an emergency is hereby declared to exist and this ordinance shall take effect immediately upon its passage by the Council and approval by the Mayor.
