An ordinance rezoning certain property from a County EFU-40 (Exclusive Farm Use - 40-acre minimum) zone to a City R-1 (Single-family Residential) zone and a City F-P (Flood Area) zone on approximately 15 acres of land located at the northerly terminus of Pinehurst Street.

RECITALS:

The Planning Commission received an application from Lester M. Cushman for a zone change (ZC 2-92) dated February 13, 1992, for property located at the northerly terminus of Pinehurst Street, and further described as a portion of Tax Lot 1001, Section 17, T. 4 S., R. 4 W., W.M., and Tax Lot No. 1100, Section 17, T. 4 S., R. 4 W., W.M.

A public hearing was held on March 12, 1992, at 7:30 p.m. before the Planning Commission after due notice had been given in the local newspaper on March 4, 1992, and written notice had been mailed to property owners within 300 feet of the affected property; and

At said public hearing, testimony was received, the application materials and a staff report were presented; and

The Planning Commission, being fully informed about said request, found that said change conformed to the review criteria listed in Chapter 17.72.035 of Ordinance No. 3380 based upon the material submitted by the applicant and findings of fact and the conclusionary findings for approval contained in the staff report, all of which are on file in the Planning Department, and that the zone change is consistent with the Comprehensive Plan; and

The Planning Commission approved said zone change and has recommended said change to Council; now, therefore,

THE CITY OF McMINNVILLE ORDAINS AS FOLLOWS:

Section 1. That the Council adopts the findings and conclusions of the Planning Commission, staff report on file in the Planning Department, and the application filed by Lester M. Cushman.

Section 2. That the property described in Exhibit "A," which is attached hereto and incorporated herein by this reference, is hereby rezoned from a County EFU-40 (Exclusive Farm Use - 40-acre minimum) zone to a City R-1 (Single-family Residential) zone (above the 100-year flood plain elevation), and a City F-P (Flood Area) zone (below the 100-year flood plain elevation).
